Dual Degree Program in collaboration between the University of Turin - Department of Management/SAA and the University of Reading

The Department of Management/SAA is pleased to announce a call for students to participate in the Dual Degree Program in collaboration with the University of Reading.

Program Overview

This Dual Degree Program allows students to earn a Master's degree from both the University of Turin and the University of Reading. UniTO Students will spend their first year at the University of Turin and have the option to choose between two majors offered by the University of Reading for their second year:

1. [Master in Business Economics](#) (SPEIR School)
2. [Master in International Accounting and Finance](#) (Henley Business School)

Program Structure

- Year 1 - University of Turin:
 - Core courses in business administration and economics
- Year 2 - University of Reading:
 - Specialized courses in either Business Economics or International Accounting and Finance
 - Research projects and Thesis preparation

Please note that, in order to complete both Master programmes and obtain the final titles, students are required to discuss the final dissertation in UoR and in UniTO as well.

Admission Criteria

- obtain 68 ECTS by July, 31st of the first year (meaning that students have successfully completed their first year at Torino)
- obtain IELTS: fulfillment of the entry admission requirements set by each Programme
- Academic excellence and a strong motivation to pursue a dual degree.
- At the time of departure for the planned mobility, the selected students must be duly enrolled at University of Turin and up to date with UniTO tuition fee payments.

Available Positions

- Master in Business Economics: 5 students
- Master in International Accounting and Finance: 5 students

Application Process and Important Dates

- Students interested in applying for this Program have to fill in a [Google Form](#) by the deadline of January 31st.
- Candidates are required to write a motivational letter and send it to mdmba.management@unito.it by January 31st
- Students can choose up to 2 programs, in order of preference
- Eligible applicants have to participate in a motivational interview (to be held within the first 2 weeks of February). The date and time of the interview will be communicated to candidates after the deadline for the submission of the application
- Admitted students will be appointed by the end of February 2024

Selection of applications and ranking

The final ranking will be drawn up on the basis of the score obtained by the individual candidates, according to the following criteria:

- credits registered in the student's booklet by January 31st
- grade point average of the exams taken and already registered in the booklet
- motivational interview
- The ranking list will be published on the Business Administration Master's degree website by the end of February

Program Costs and Scholarships for UniTO students

UniTO students on the Dual Master's Programme will be entitled to a 20% fee discount on the standard international tuition fees for the UoR Master's Programmes in Business Economics and International Accounting and Finance.

Students will be responsible for meeting all their own costs for participating in the Dual Master Programme including: accommodation, travel, adequate travel and medical insurance, textbooks and all other costs.

Students are required to pay the UniTO ordinary fees whereas they are exempted from the payment of the yearly additional contribution for the second year.

Admitted students should check for eligibility of the Scholarships provided by UoR.

In case of grants provided by the Department of Management/SAA, Applicants will be automatically appointed. Further communication will follow later on.

4. Specify the master chosen (Business Economics or International Accounting and Finance) for the second year.
