ASSIGNMENT CRITERIA

- The scholarships will be awarded **ex officio** (automatically), on the basis of the data available in the student's career and on the credits recognized by **31 July 2021**.
- Careers will be evaluated by committees set up for this specific purpose.
- Scholarships will be awarded to regularly enrolled students* who have obtained the **highest weighted average** (excluding elective courses, free credits and pass-or-fail examinations/ "idoneità").
- In the event of absolute equality between two or more students, the amount of the scholarship will be equally divided among those entitled.
- careers of students enrolled for more than two years ("fuori corso") will not be taken into consideration, except those students who have passed and registered all exams and should exclusively defend their thesis (graduating students);

The above-mentioned scholarships <u>CANNOT</u> be combined with scholarships awarded by EDISU (even if you are applying for an EDISU scholarship) or other scholarships provided either by public or private bodies.

* Students must be regularly enrolled or graduated in Business Administration program at the moment of scholarship awarding and make sure that all due payments have been settled.
