## **SUPPORT TO THE INTERNATIONALIZATION OF SAA STUDENTS SCHOLARSHIPS REGULATION**

The Department of Management "Valter Cantino", in collaboration and equal financing with FINSAA (Associazione per il Finanziamento Studi in Ambiti Aziendali), in the framework of the provisions adopted to support the internationalization of the students enrolled in the 2022/2023 academic year in the **Business Administration Master's Degree** held by SAA - School of Management, has provided that:

### **for the Master's Degree in BUSINESS ADMINISTRATION**

N. 3 SCHOLARSHIPS for the dual degree with University of Reading (UoR, UK).  
The scholarships will be granted according to the criteria indicated below.

#### **ADMISSION REQUIREMENTS and SCHOLARSHIP GRANTING**

- **N. 3** scholarships amounting to **€ 5.000,00** (five thousand/00) each to the best students. Details on the required documents are specified in the application link → **BA READING MOBILITY**

#### **ASSIGNMENT CRITERIA for scholarships subject to application (BA READING MOBILITY)**

- In order to apply to these scholarships students must fill in the application form by April 17<sup>th</sup>, 2023
- Students must have passed all their first-year exams and registered 68 CFU by July 31<sup>st</sup>, 2023.
- The application's evaluation will follow a merit-based scale. In the event of other conditions being equal, the Committee will also consider students' career.
- Winners will receive the scholarship divided in 2 instalments:
- 50% upon presentation of the receipt of payment of the first UoR (UK) instalment.
- 50% upon presentation of the receipt of payment of the second UoR (UK) instalment.

### **GENERAL ASSIGNMENT CRITERIA**

- Students must be regularly enrolled in the Business Administration program at the moment of scholarship awarding and make sure that all due payments have been settled. Students enrolled on the basis of specific agreements with other schools or universities and in general with other supports that exempt students from paying SAA's additional contribution (art. 3.2 and 3.3 of the "Regolamento Tasse e Contributi UniTO") are excluded from the evaluation;
- In the event of further availability of funds or fewer applications than the available grants, the amount of the scholarship will be equally divided among the candidates entitled. Nevertheless, the amount of each grant would not be more than 10,000€.

The above-mentioned scholarships **CANNOT** be combined with **scholarships awarded by EDISU** (even if you are applying for an EDISU scholarship), but **CAN** be combined with **other scholarships provided either by public or private bodies (included merit-based scholarships awarded by SAA)**.
